Background:

The Bihar State Educational Infrastructure Development Corporation, (BSEIDC) is engaged in developing and upgrading the infrastructure of education institutions in the state of Bihar. BSEIDC in concurrence from State Council of Educational Research and Training (SCERT) and Education Department, Government of Bihar intends to augment the capacity of Teacher Education institutions/centres by setting up ICT facilities and related infrastructure to introduce online distance learning programs. As part of this endeavour, the BSEIDC intends to retrofit/upgrade the buildings of Teacher Education institutions/centres at about 1200 locations spread across the state of Bihar.

Letters for Expression of Interest (EoI) are invited from qualified and experienced technical consultancy firms who wish to apply for the assignment – 'Selection of Technical consultancy firm for assessment of civil works required for retrofitting of the Teacher Education institution/centres for setting up of ICT facilities'.

The objective of this call for EoIs is to short-list and qualify technical consultancy firm(s) for undertaking detailed assessment of the existing buildings at each of the location and submit a detailed plan along with bill of quantities required for retrofitting or upgrading the buildings.

Scope of work:

Govt. of Bihar intends to create/ramp up 'Teacher Education' institution capacity and also roll out ICT platform as a tool to achieve professional development and management of the teachers.

As a part of this initiative, it is envisaged to set up ICT facilities in approximately 1200 teacher education institutions spread across the state. As most of the teacher education institutions have buildings which are mostly in dilapidated condition and require major repair, Govt. of Bihar intends to upgrade the buildings/ physical infrastructure by undertaking repair works or retrofitting of the buildings to enable the setting up of ICT facilities. Govt. of Bihar intends to roll out this in 3 (three) phases covering the all the 1200 study centres.

The objective of the consultancy is to undertake technical studies and prepare a detailed report for each of the location for firming up the BSEIDC's requirements in respect of retrofitting the buildings, quantify the amount of civil works required and enabling the prospective civil works contractors to assess the Authority's requirements in a clear and predictable manner.

The consultant is expected to undertake following activities:

- 1. Undertake planning exercise to verify compliance of the study centres with project parameters
- Assessment of existing building in terms of structural stability and safety aspects
- 3. Assessment and quantification of civil works required to comply with the norms
- 4. Assist in preparation of tender documents and selection of civil works contractor for executing the identified works

5. Supervise the construction activities undertaken by civil works contractor for retrofitting the buildings

Expected outputs from the technical consultant are:

- 1. Assessment and investigation reports on structural stability, safety aspect etc
- 2. Set of technical/construction drawings with proposed furniture layout, electrical layout, utilities etc
- 3. Preliminary costing and bill of quantity for each of the centre
- 4. Implementation schedule

Criteria for evaluation:

The applicant who is interested in being considered for this assignment should fulfil the following criteria:

Mandatory:

- 1. The applicant should be a firm /company registered/incorporated in India under the Companies Act, 1956, Trust Act or registered in India under the Society Registration Act, 1860.
- 2. The applicant should possess at least 5 years of experience in the field of civil engineering/ architectural consultancy with at-least 1 project of planning, designing, supervising the construction works of an educational institution.
- Turnover of at least INR 6.00 crores per annum during last three consecutive years.
- 4. The agency should have adequate staff strength and experts having experience and professional qualification. Brief CVs highlighting the experience listed should be shared. The agency will be asked to furnish complete details at the RFP Stage

Desirable:

The applicant should have the resources to undertake detailed assessment of buildings, preparation of retrofitting plan, for a Central/ State Government. The applicant will be asked to furnish appreciation letter with completion certificate from relevant Government Department that they have worked with.
