***General Instruction:**

1. The appointment, if on deputation basis will be for the period of 3 years and as per the deputation rules of Govt. of Bihar.
2. The appointment, if on contract/re-employment from retired officials of Govt. of Bihar, will be as per the terms of GAD circular No **2804, dt24.03.2010**.
3. The appointment, if on contract basis from market, the fixed emolument of Rs 55,000 will be paid and will be for one year which may be renewed annually depending upon the satisfactory performance.
4. The upper age limit (as on 01-03-13) for all posts shall be 50 years (57 years in case of deputation and 64 years in case of retired personnel)
5. The prescribed qualification should be as regular student of a full time course from a recognized university/Institute.
6. Wherever Grades are awarded in the Diploma/Degree Examination its equivalent percentage of marks must be indicated in the application form as per the norms adopted by the University/Institute.

A DD of Rs.500/- (Five hundred) as application fee (non refundable) in favour of **Bihar State Educational Infrastructure Development Corporation Ltd payable at Patna** to be sent alongwith application.
