### CONDITIONS OF CONTRACT

Clause 1:- All compensation or other sums of payable by the contractor t Government under the terms of his contract may be deducted from, paid by th sale of a sufficient part of his security deposit or from the Interest arising therefor or from any sums which may be due or may become due to the contractor b Government on any account whatsoever and in the event of his security depos being reduced by reason of any such deduction or sale as aforesaid, the contract shall within ten days there after make good in cash or Government securities endorsed as aforesaid any sum or sums which may have been deducted from, arised by, sale of his security deposit of any part thereof.

The work should not be considered untill such date as the Executive Engineer shall certify as the date on which the work is finished after necessary rectification of defects as pointed by the contractor to the Engineer's satisfaction.

Clause 2 :- The time allowed for carrying out the work as entered in the tend shall be strictly observed by the contractor and shall be reckoned from the date of which the wirtten order to comence work is given to the contractor. Clause 12 (a) The contractor shall not be entitled to claim any compensation for loss suffered by him on account of delay by or on behalf of Government in the supply of materials as stores which the Government may have undertaken to supply where such failure is due to:

(i) natural calamities, (ii) act of enemies, (iii) transport and procurement difficulties or (iv) circumstances beyond the control of the state Government.
