Clause 1:- All compensation or other sums of payable by the contractor Government under the terms of his contract may be deducted from, paid by the sale of a sufficient part of his security deposit or from the Interest arising therefor or from any sums which may be due or may become due to the contractor : Government on any account whatsoever and in the event of his security depos being reduced by reason of any such deduction or sale as aforesaid, the contract shall within ten days there after make good in cash or Government securite endorsed as aforesaid any sum or sums which may have been deducted from, a arised by, sale of his security deposit of any part thereof.

Clause 12 (a) The contractor shall not be entitled to claim any compensation for loss suffered by him on account of delay by or on behalf of Government in the supply of materials as stores which the Government may have undertaken to supply where such failure is due to:

(i) natural calamities, (ii) act of enemies, (iii) transport and procurement difficulties or (iv) circumstances beyond the control of the state Government.

In case of such failure in delay in the supply of materials or stores on an application by the contractor within 30 days form the date of such failure or delay, such extension of time shall be granted to the contractor for completion of the work as shall appears to the Engineer to be reasonable in accordance with the circumstances of the case.
